MINUTES

The President, Jose Antonio Gonzalo, chaired both General Assemblies.

On Thursday, 1st April 2004, he opened the 1st EAA General Assembly explaining that the reason for having two meetings this year was due to the fact that the proposed new corporate governance and consequently the revision of the statutes needed to be approved. The changes would be presented in this first meeting while the approval would be asked for during the second meeting, as there was no need anymore for a minimum quota of attendance.

The President presented the new structure of the EAA. Full details can be found in Annex I.

No further points were raised and the 1st General Assembly was adjourned.

On Saturday, 3rd April 2004, the President opened the **2nd EAA General Assembly**.

1. Approval of the minutes of the General Assembly 2003 - Seville

The minutes of the General Assembly 2003 in Seville were approved.

2. Results of Elections & Officers for 2004/2005

The President announced the results of the elections:

4. New EAA Corporate Governance

The President gave a guick overview of the proposed new corporate governance that had been explained during the 1st General Assembly.

He then asked for the formal approval of the proposed amendments as well as for the revision of the statutes, which had been sent via e-mail beforehand.

Both the amendments and the revised statutes were approved by consensus.

The President explained that the next steps dictated by the new corporate governance would be the election of the future President as well as of the Management Committee members.

He then briefly presented all the operating committees and their members. When mentioning the Conference Committee, he thanked Stefano Zambon for the good work he had done during the past 6 years.

5. Accounts 2003

The President showed the following figures:

and reported that the *income* slightly increased compared to 2002. The main reason for this being that Taylor & Francis, the publisher of the journal, made a balance of royalty payments over the past 4 years.

The *expenditures* did not significantly change compared to last year. Except for the travel & accommodation expenses, which were reimbursed for a Steering Committee meeting held in Brussels to discuss the new corporate governance.

As to the *balance sheet*, substantial difference between the 2 years is due to the fact that at the closure date of the accounts, a series of due amounts had not yet been received, the most important one being the membership fees 2003 (total of 42.800 €).

The accounts 2003 (full details in Annex II) were approved.

8. Report on the EAA Doctoral Colloquium 2004

John Christensen, one of the co-chairs of the Doctoral Colloquium, reported that this year's Doctoral Colloquium – now sponsored by KPMG – was held in a very nice place close to the German border.

This year 65 applications had been received representing a remarkable increase vs last year (53). The 17 students selected represented schools from 12 countries. This included the representative from AAA, Hui Chen, from the University of Tennessee.

In addition to the students' presentation, Jan Mouritsen and Wayne Landsman gave a plenary lecture.

The faculty selected Martin Kleinert from the University of Tübingen to represent the EAA at the forthcoming AAA Doctoral Consortium.

John thanked Tom Groot, the 2nd co-chair, who announced that he had decided to resign, for his commitment and contribution to the success of the past colloquia.

9. Report on the EAA Annual Congress 2004

Ladislav Mezlik, the Secretary General of the Prague Congress, reported the following figures

Ladislav briefly explained the "Abstract Assessment Process" used, i.e. each abstract had been reviewed blindly simultaneously and anonymously by 2 independent members of the Scientific Committee, who were originating from different countries.

Bohumil Kral, the Chair of the Prague Congress, expressed great thanks to all those had contributed to the success of the conference.

10. Report on the EAA Annual Congress 2005

Olov Olson, the Chair of the EAA Congress 2005, introduced his Secretary General, Gunnar Rimmel and his Treasurer, Jan Marton. He mentioned that a leaflet had been distributed.

He announced that the congress would take place from May 18-20 at the School of Economics and Commercial Law, Göteborg University (SEC). The Doctoral Colloquium would take place from May 14-17 on the Gullholmen Islands.
