MINUTES

1. Approval of the minutes of the General Assembly 2006 - Dublin

Neither questions nor comments were made. The minutes of the General Assembly 2006 in Dublin were approved.

2. Report from the President

The President reported briefly on ongoing initiatives, and in particular:

<u>FRSC</u>

Under the leadership of Günther Gebhardt, the Financial Reporting Standards Committee had been working hard and was involved in different projects increasing their visibility in this way.

IAESB

Being part of the IAESB's Consultative Advisory Group was important for the EAA as they were discussing how education and teaching should be developing.

Global Digital Archive

The project, initiated by the President-elect of AAA, had been set up further to the concern that material of scientific value might get lost unless some action was taken to preserve it. The idea was to create an electronic archive of accounting data accessible from everywhere. John thought that this was a most valuable project as it will help us to maintain our history.

Composition of Board

John reminded that currently the Board comprised National Coordinators of all countries with more than 10 members + one US co-opted Officer.

Part of the world represented by a growing number of members and exceeding 10 were not represented on the EAA Board, namely Asia, Australia, Eastern Europe and South Eastern Europe. A scheme for those regions to be represented in the future on the EAA Board would be developed.

Conference organisation

The Management Committee intends to analyse the possibility to "centralise" the administration of the annual conferences in order to maintain the learning in house and to reduce the financial risk on the side of the conference organisers.

Carlos reported that the conference budget was amounting to 850.000€. At one point in time, he was quite worried as the facilities were very expensive. But the huge number of delegates would allow now to foresee a small profit and at least no loss.

On behalf of all EAA members, the President thanked Carlos and his team for all the energy and time put in the preparation of this successful conference.

5. Report on the EAA Doctoral Colloquium 2007

Peter Pope, one of the two co-chairs of the Doctoral Colloquium, reported that this year's Doctoral Colloquium, was held 21-24 April 2007 at the Tivoli Hotel in Sintra.

The nine faculty members on the Colloquium spanned the various research paradigms relevant to accounting research and included the following:

- Alfred Wagenhofer, University of Graz

In addition, Professor T.J. Wong, Chinese University Hong Kong, attended on the final day. Plenary workshops were given by Peter Miller and T.J. Wong.

Applications were received from 77 PhD students from across Europe. Including the nominee from American Accounting Association, Sarah Zechman (Wharton School, University of Pennsylvania), 27 students were selected to attend the Colloquium. This is an increase of 50% on the number of students attending in previous years.

Students were organised into three streams, broadly covering (A) Capital Markets Research and Accounting Choice, (B) Management Accounting, and (C) Social and Environmental Accounting.

Based on her presentation, contribution to discussion and the overriding criterion of expected benefits to be derived from attendance, faculty members selected Yasmine Chahed (London School of Economics) to represent the EAA at the American Accounting Association Doctoral Consortium in Tahoe in June 2007.

6. Report on the EAA Annual Congress 2008 - Rotterdam

Frank Hartmann, the Chair of the EAA Annual Congress 2008, started by thanking in particular the Lisbon and Dublin organisers for their help and support in this initial phase.

He announced that the congress would be hosted by the Erasmus University Rotterdam and held from 23-25 April 2008 at the Erasmus Expo & Congress Centre, which is located on the campus of the university.

A "first announcement" brochure including more detailed information, such as the programme outline, the key dates, practicalities, etc. had been put in the Lisbon conference bag.

He mentioned that several new features would be introduced:

- Only full paper submissions will be considered for acceptance.
- There will be discussants for selected parallel sessions.
- Some Best Paper Awards will be given for selected paper categories

He was hoping that the most important change, i.e. only full paper submissions, would not lead to a drop in the number of delegates but would lead to an improvement of the conference quality.

He also mentioned that Ernst & Young will be the main sponsor while Deloitte and KPMG will also contribute.

7. Future congresses

Ann Jorissen, the Conference Committee Chair, announced the future locations of the EAA Annual Congresses:

- Rotterdam, 23-25 April 2008
- Tampere, 12-15 May 2009
- Istanbul, 19-21 May 2010

She reminded that the EAA conference guidelines had been posted on the EAA website and invited potential future hosts to look at them and to contact her if they were interested.

On behalf of the Conference Committee, Ann thanked Carlos Baptista da Costa for the hard job he put in organising this event.

8. Election of President-elect

It was reminded that according to the new corporate governance, the President's first term of office is 2 years and is renewable for 1 additional year. The election for the President-elect had therefore to be launched in 2007. During their interim meeting in September 2006, the Management Committee had asked John to stand for the additional year. He accepted and his nomination was subsequently approved by the Board.

The President asked if there was any objection. As no objection was made, the election was approved.

The President thanked the Assembly and mentioned that he would revise the statutes before leaving the Presidency, and in particular the election procedure.

9. Miscellaneous

The President, John Christensen, once again thanked all the persons involved in the organisation of the EAA Annual Congress in Lisbon. He also thanked the Management Committee for helping him to manage the Association smoothly as well as all the other EAA committees for their contribution.

One EAA member expressed his appreciation of the work done by the Scientific Committee and in particular Willem Buijink.

As no further points were raised, the General Assembly was adjourned.
