Minutes

1. Welcome, apologies and adoption of the agenda

The President, Salvador Carmona (SC), welcomed all members present.

2. Matters arising

No matter arising was raised.

ITEMS FOR REPORTING/NOTING

3. President's update

The President alerted the MC on the following two issues with the only purpose of being aware of it:

- 1) Donald Trump's decision to prevent people from several countries (incl. students) from returning to the US.
- 2) Case of fraud email.

4. Treasurer's update

4.1. Preliminary EAA accounts 2016

Saverio Bozzolan (SB), the Treasurer, presented the provisional Accounts 2016 (see Appendix 4.1+ 4.2).

The YTD December 2016 figures are shown in comparison to the Budget 2016 and to the Actual 2015.

4.2. Savings and investments

After showing an overall picture of the financial status, SB recalled the investment strategy he proposed during the October 2016 MC meeting and approved by the MC

5. Congress updates

5.1. Update on the preparations for the EAA Congress 2017, Valencia

Begoña Giner (BG), the Chair of the EAA Congress 2017, reported that preparations were ongoing as announced in earlier meetings. She referred to the revised budget they had prepared (see Appendix 5.1).

Beatriz Garcia Osma (BGO), responsible within the Valencia team for following up on the symposia, reported that close to all of them were organised. She was still waiting for the responses of some scholars she had invited recently. The main issue she had had to face was to avoid overlap between the sponsored symposia and the academic symposia.

BG mentioned that she had already contacted IFRS for the Teaching Workshop and that a first conference call regarding the conference app was scheduled for the week after this meeting.

The President congratulated BG and her team and wished them well for the final preparations.

5.2. Update on the preparations for the EAA Congress 2018, Milan

Miles Gietzmann (MG), Chair of the EAA Congress 2018, and Annalisa Prencipe (AP), Member of the EAA Congress 2018 team, referred to their slide presentation (see Appendix 5.2) focusing on the novelties compared to what had been reported in the October 2016 meeting, i.e. in particular:

- the venues for the gala dinner;
- the venues for the EAA Doctoral Colloquium;
- the promotion leaflet was ready to be distributed in Valencia;
- the banner for the website was ready → it was pointed out that the dates of the Doctoral Colloquium should be included in the banner;
- the Italian VAT registration was completed;
- the budget had been substantially revised: some costs were deleted and some others redimensioned allowing for the fees to be reduced:

early bird fee 450€ regular fee 520€ onsite fee 570€ accompanying person 250€

AP referred to two open issues:

- Conference book → the MC confirmed that no hard-copy version of the conference book needed to be produced anymore;
- 2. Hotel booking → the MC confirmed that a hotel booking service was mandatory.

The President thanked MG and AP for their presentation and for the work done so far.

5.3. Update on the EAA Congress 2019, Paphos

The President referred to the preliminary budget for the EAA Annual Congress 2019 (see Appendix 5.3). No major issue was identified.

6. Doctoral Colloquium and Congress issues

6.1 Future conference venues

The President thanked Matias Laine (ML), the EAA Conference Committee Chair, for his excellent follow up on future congresses and for having provided 3 proposals for 2020-2021-2022 as well as preliminary budgets (see Appendices 6.1a to 6.1g) for Bucharest, Aalto and Vilnius.

6.2 Attendance of EAA student at AAA Doctoral Consortium

Beatriz Garcia Osma (BGO) explained that a request for nominating the EAA student who would attend the AAA DC 2017 to be held June 14-18, 2017 in Westlake, Texas had been received. The deadline for nominations was December 16, 2016, which could not be met given that the EAA student is selected from among the PhD students attending the EAA DC 2017 in May. It was agreed to stick to the current process for the selection of the EAA doctoral student entitled to attend the AAA Doctoral Consortium.

7. Governance issues

7.1 Nominations

The President reported on a series of nominations to be approved by the MC.

MC Members (2017-2020)

As usual a long list of scholars had been nominated by the EAA members for membership to the Management Committee.

The MC unanimously approved the nominations of the candidates proposed, which would be submitted to the Board's approval after this meeting.

The President considered that it may be good to review the corporate governance rule in this respect.

PC Member (2017-2010)

The President welcomed Giovanna Michelon, the candidate proposed by the PC and already approved by the MC, on the EAA Publications Committee in replacement of Peter Walton.

On behalf of the MC, the President expressed the immense debt of gratitude that EAA has towards Peter, who has been fundamental in enhancing both its academic profile (e.g., EAR, AinE) and its professional impact (e.g., international, professional associations).

SSC Member (2017-2020)

On behalf of the MC, the President thanked SSC Chair Ralf Ewert and the entire Standing Scientific Committee for the great job done so far for the Valencia congress.

SC will ask Ralf to come up in Valencia with a candidate to replace - if needed - the SSC member whose term of office came to an end this year.

7.2 Result elections Board members (2017-2020)

The President referred to the document listing the elected National Representatives, which had been circulated prior to the meeting (see Appendix 7.2).

8. PhD support and training

8.1 EAA Academic Resource Centre (EAA-ARC)

Philip Joos (PJ) complimented the ARC team members following up on the events, who started in 2016 and who were working together in harmony. No changes were foreseen among the various ARC Committee Editors

The next platforms to be launched were the PhD review and the PhD Forum.

On behalf of all MC members, the President congratulated Thorsten Sellhorn for the great job he had done with the ARC and thinking in terms of continuity he suggested to ask Thorsten if he was willing to stay on the team. The MC unanimously approved SC's proposal.

8.2 Academic first paper consultancy service

Beatriz Garcia Osma (BGO) reported that James Cleaver from T&F had sent a draft contract for hosting the PhD review on their Scholar 1 platform.

8.3 EAA PhD Forum 2017

Philip Joos (PJ), one of the co-organisers of the PhD Forum 2017, skimmed through the programme proposed.

He mentioned that it would be good to have someone who attended a previous workshop and was recruited via the EAA job market.

8.4 EAA job market: Talent Workshops 2016 and 2017

The President reported that the EAA Talent Workshop 2016 had attracted 58 recruiters including major European institutions.

The MC members agreed that future events of the Workshop would be held in Madrid.

9. EAA membership

9.1 Membership services

9.2 Update on Task Force "Diversity"

The President referred to the report written by Philip Joos (PJ) and Lisa Evans (LE) reflecting on the possibilities to increase the membership benefits for EAA members (see Appendix 9.1), and in particular in terms of:

- networking at conferences
- having access to more resources
- benefiting from funding
- developing career development opportunities

It was agreed that PJ and LE's idea to conduct a members' survey to find out what other services would be good to do in the short run. It could be sent to current and past EAA members. It could also be asked to national accounting associations to run it among their members.

The President summarised the MC decisions as follows:

- a series of interviews will be conducted (SC);
- a survey will be ready for circulation by May (PJ/LE);
- a communication policy will be put in place (PJ);
- special panels will be organised during the EAA 2018 congress (AP will check with AAA with the help of PJ);
- an effort to improve the quality of the conference will be made (SC will contact the SSC Chair, Ralf Ewert).

The President referred to a proposal made by Ann Jorissen regarding the possibility of organising sessions on "good teaching practices" during the EAA congress. The MC approved to run one first teaching session during the EAA 2017 congress.

10. Interaction with other organisations

10.1 National Accounting Associations - Reception 2017

The President informed that a reception for representatives of national accounting associations would be organised again in Valencia, as it had been the case last year in Maastricht. The invitation will be sent in the month of March 2017.

10.2 Collaboration EAA-ASEPUC

The President mentioned that he would invite the President of ASEPUC to the reception in Valencia and discuss with him the possibility of establishing a stable relationship between both associations.

10.3 IASB Research Forum 2017

The President referred to the invitation drafted by Ann Jorissen for the EAA-IASB Research Forum that will be organised in November 2017 in Brussels, as well as to her proposed list of guests.

10.4 Collaboration EAA-IASB

This topic was not further discussed.

10.5 Nominations to EFRAG

The President referred to the EFRAG Call for Candidates for its Academic Panel.

10.6 Collaboration with ANPCONT

The President considered that it would be good to have a strong relationship with Latin America.

11. EAA Awards

The President reminded the MC members that it had been decided earlier not to give any particular award in Valencia. A nice video giving the floor to all past Congress Presidents will be presented.

12. Any Other Business

12.1 Minutes of MC meetings

The President recalled the current procedure regarding the MC minutes:

No other question or remark was made. The President thanked all MC members for another excellent meeting and wished them a nice trip back home.
