Candidates must possess a do degree in accounting or closely related field from an internationally accredited institution and have an excellent academic record in both research and teaching. Successful candidates must have an outstanding publication record and an active research program with the demonstrated ability or clear potential to be publish highly ranked academic journals (such as ABS level 4 \* or 4 journals). International research experience and collaboration are highly valued.

In addition to research activities, the position involves teaching, supervision and some administrative work. Candidates will be evaluated based on their docume professional competence overall, including their past academic record, current work in process and evidence of teaching effectiveness. Candidates that cannot document at least 200 hours of pedagogical coursework when hired must complete the NHH programme on basic pedagogical competence within two years. Appointees who are not fluent in a Scandinavian language will be offered Norwegian language classes.

In the assessment of applicants, international experience and qualifications will be emphasized. In the event of equivalent qualifications, female applicants will preference. Best-qualified candidate(s) will be invited for an on-campus interview.
