## Position description:

The Department of Accountancy at the John Molson School of Business invites applications for a Tier I Canada Research Chair (CRC) position in Sustainability Reporting at the rank of Associate Professor or Professor. The granting of tenure on appointment will be considered in accordance with the provisions of the CUFA collective agreement. Researchers in all areas of accounting and sustainability are welcome to apply. This includes, but is not limited to thematic areas, such as questions of sustainability and accountability, measurement, control, performance, disclosure, or assurance.

The selected candidate will join a collaborative research environment, encompassing a well-institutionalized Concordia Accounting Research Seminar Series, PhD-Faculty Research Festivals, and food-for-thought working paper presentations. The Tier I CRC in Sustainability Reporting will drive the development of multi-disciplinary collaborative research in sustainability and accounting. In particular, the expectation is to foster research collaboration across Departments and Faculties, secure significant external funding, and strengthen the School's research-based graduate programs in the advertised disciplinary area. In doing so, the selected candidate will benefit from John Molson's and Concordia's existing capacity in sustainability research, which includes multiple donor- and university-funded professorships, research centres, and institutional initiatives. They will further leverage and partake in these and other multi-disciplinary initiatives, such as the Loyola Sustainability Research Centre and the Sustainability Hub. The department sees a unique opportunity to engage actively in policy discussions and standard-setting conversations, following the recent opening of an ISSB office in Montreal.

# Qualifications and assets

The candidate for the position must have a PhD, a strong academic research program, and evidence of teaching effectiveness. They should also have experience with multi-disciplinary research in sustainability reporting, broadly defined, and a recognized research record in that area. The candidate should further have demonstrated potential to drive the development of programs and structural change, preferably across disciplinary boundaries. Organizational skills, honed within or outside the academy, are necessary—as is the ability to collaborate.

The ability to establish partnerships with external actors and to lead multidisciplinary research projects are strong assets. Candidates may wish to highlight their capacity to attract graduate students and participate in curricular development.

Candidates eligible for Tier I chair positions must be outstanding researchers acknowledged by their peers as world leaders in their fields. Nominees for Tier I Chair positions must be full professors or associate professors who are expected to be promoted to the full professor level within one or two years of the nomination. Alternatively, if they come from outside the academic sector, nominees must possess the necessary qualifications to be appointed at these levels. Candidates are encouraged to share any career interruptions or personal circumstances that may have had an impact on their career goals (such as the decision to have a family, eldercare, illness, and so forth) in their letter of application. These will be carefully considered in the assessment process. The Department values diversity among its faculty and strongly encourages applications from those who will contribute to that profile. Concordia University is an English-language institution of higher learning at which the primary language of instruction and research is English. Since this position supports academic functions of the university, proficiency in English is required. Working knowledge of French, including reading and grading student work in French, is an asset.

All qualified candidates are encouraged to apply; however, Canadians and Permanent Residents will be given priority. - three most important research contributions to date or three representative publications;
- recent teaching evaluations or other evidence of teaching effectiveness.
