COMPETITION FOR THE CONFERRAL OF NO. 5 ANNUAL POST-GRADUATE SCHOLARSHIPS FOR SCIENTIFIC AND EDUCATIONAL TRAINING AT UNIVERSITÀ COMMERCIALE "LUIGI BOCCONI" OF MILANO.

Article 1

Università Commerciale "Luigi Bocconi" of Milan, to help start the training for scientific research and teaching activities of young graduates, publicizes a competition using only qualifications, for the assignment of **No. 5 Annual post-graduate scholarships** in the Department of "Accounting" for the academic recruitment field:

13/B1 BUSINESS ADMINISTRATION AND ACCOUNTING STUDIES

(SECS-P/08 Business Administration and Accounting Studies)

Tutor: prof.ssa Annita FLOROU

Article 2

Admission Requirements

In order to participate in the competition the candidate must be an Italian citizen or foreigner holding a degree or graduating with previous teaching qualifications, achieved no more than two years before the date of this competition.

In the case where the degree was obtained abroad, it must have lasted at least four years and must be recognized as valid for admission to this competition by the Selection Committee referred to in article 4 of this competition notice.

Candidates may obtain a conditional acceptance. At any time, the administration can arrange, with reason, exclusion from the selection procedure due to the lack of necessary pre-requisites.

Article 3

Applications

Applications completed according to the attached form, addressed to the Rector of Bocconi University, must reach to the "Faculty and Staff Administration" office via e-mail before **12 noon of 21 July 2021**, to "recruiting-adr@unibocconi.it")

Each candidate's application must clearly indicate:

- surname and name;

- date and place of birth;
- fiscal code;
- citizenship;
- residence;
- educational qualifications.

The application must include the following documents, which must be attached to the application:

- degree certificate with the grades for each individual exam taken;
- C.V. of studies carried out;
- any publications or printed articles or degree thesis;
- any certificate or document proving your scientific and teaching preparation in the field pertaining to the Department of referral and the scientific area of the SDA Bocconi Business School, which the candidate intends to submit for evaluation.

Article 4 ***Judging Committee***

The Judging Committee shall be appointed by the Rector and consists of three members of the faculty, including the Department Head or his delegate.

The competition will be carried out by an evaluation of titles and qualifications.

At the conclusion of the evaluation, the Committee shall issue an overall judgment on the qualifications presented to each candidate and nominate the winning candidates.

Successful candidates will be given written notice of the award of scholarship and the indication of their tutor of referral. This communication, under penalty of forfeiture, must be signed for acceptance by the deadline of 15 days.

The scholarship cannot be shared and is given on an individual basis. If for any reason the candidate stops receiving the scholarship, they cannot be substituted by other candidates who did not win a scholarship.

Article 5 ***Rights and Duties of the Scholarship Winner***

The scholarship has an annual duration and will run from the **1st of the month** following the assignment of the scholarship.

Conferral of the scholarship implies a commitment to undertake study and research for at least four days a week, based on the indications of the Full Professor of the Department of referral and of the Tutor assigned to look after the scholarship holder.

The scholarship holder is also obliged to carry out 50 hours of teaching assistance at the University, for the courses communicated by the Tutor of referral.

The scholarship holder cannot carry out any type of teaching activity.

The conferral of the scholarship does not constitute an employment contract and does not confer any rights to teaching roles within the University.

The enjoyment of the scholarship cannot be combined with the enjoyment of any other scholarship provided by Bocconi University.

Three months before the end of the annual scholarship, the Professor and Tutor of reference express, for the Director of the Department, an evaluation report on the activity of the scholarship holder and of his/her potential for the further study in PhD courses in Italy or abroad supported by scholarships of Università Commerciale "Luigi Bocconi".

The scholarship holder can give up their scholarship in any moment.

The Department Director can propose the extension of the scholarship for up to a maximum of 6 months.

Article 6 ***Economic Compensation***

The amount of the scholarship is **€ 8.000,00 gross per annum**.

The payment of the scholarship will be made every two months post-dated, following presentation before the tenth day of each month, of a payment note, signed by the Tutor designated as the person responsible for checking the activity carried out.

The scholarship referred to in this competition notice, in accordance with applicable provisions of law on the subject, excludes any social assistance and social security. Interested parties must therefore register themselves with the competent state bodies for health care.

Article 7 ***Causes of deferral or suspension of the scholarship***

The holder of the scholarship that demonstrates the need to meet his obligations of military service or be in the conditions provided for working mothers can obtain, by showing the Faculty and Staff Administration the required documentation, the deferral of the date of commencement of enjoyment of the scholarship, or suspension of study or research activity.

Article 8
Certification of the activity carried out

At the end of the scholarship, the beneficiary has the right to ask for a certificate stating the activity carried out during their time in Bocconi University as an annual scholarship holder.

Article 9
Treatment of personal data

According to a General Data Protection Regulation n. 679/2016 all personal data supplied by candidates to the Faculty and Staff Administration, both in electronic and paper format, is exclusively for evaluation purposes and to publicize the acts related to the current evaluation procedure and the conferral of an Scholarship position as detailed in this announcement.
