## **DOCTORAL WORKSHOPS**

As part of C2ID 2026, an **international doctoral workshop** will be organized to support PhD candidates in advancing their research. This workshop is open to doctoral candidates even in the early stages of their dissertation and offers:

- In-depth feedback from experts
- Methodological and epistemological guidance

PhD candidates are invited to submit a research report (max. 8,000 words) presenting: problem statement, literature review, theoretical framework, methodology, preliminary results, and references.

A **second workshop** will be dedicated to advanced training in **structural equation modeling (CB-SEM approach)** for PhD students and faculty.
